CLEANING & CARE

Use placemats or trivets under hot items and coasters under beverages to prevent marks and stains. Wipe up spills as soon as possible with a damp cloth; finish with a dry cloth. Use a mild soap and warm water to fully clean the surface area; avoid the use of harsh chemicals or abrasive cleaning materials. Use a fine dust brush or cloth to remove dust particles at least once a week to prevent scratches. Avoid placing sharp objects on the tabletop. Do not place heavy objects directly on the surface—a protective layer of felt material at the base is highly recommended.

WARRANTY

Special-T warrants that all products shall be free from defects in workmanship or materials. All products will be built to customer's specifications. All defective product claims must be submitted in writing to Special-T within 30 days of the shipping date from Special-T. For all defective product claims, Special-T may request samples, photos, or videos demonstrating the defect before further action. No merchandise shall be returned or scrapped without prior approval from Special-T. Special-T reserves the right to refuse and return all unauthorized returns to the customer.

Special-T reserves the right to request the return of any or all of the defective products. All returned products must be inspected by the Special-T Quality Inspection Department and confirmed to be defective before the replacement process can start. This warranty excludes any type of misuse, abuse, as well as ordinary wear and tear. The foregoing warranty shall not apply to damage caused under the following circumstances: (a) modifications or attachments to the Special-T products; (b) damage caused by misapplication of cleaning product; (c) natural variations in wood grain, figure, color or the presence of character marks; (d) any handling or transportation damage to the products or (e) changes in surface finishes due to aging or exposure to light.
